The roots of Equal Justice University go back to 1977 when TALS began holding annual education and fellowship meetings exclusively for Tennessee's legal aid lawyers. This meeting grew into the Tennessee Equal Justice Conference more than ten years ago and expanded to include legal service providers across the state, both federally and non-federally funded, as well as members of legal clinics and other community advocates.
