TALS is now accepting submissions for session proposals for this year's Equal Justice University conference. In addition to the requested topics below, all submissions are

welcome, especially high-quality ethics and professional development CLE sessions. TALS' partners requested specific training in the following areas:

In **Employment Law**, requested topics include:

- Trends in employment discrimination cases
- Wrongful termination
- Employment barriers to re-entry, including driver's license revocation

Immigration, requested topics include:

- Immigration pitfalls for non-immigration practitioners
- Intersection of immigration and domestic violence issues
- Immigration and public benefits
- State and local laws affecting immigration

Family Law, requested topics include:

- Parenting plans, techniques and suggestions
- New relocation statute
- Changes in child support law and the worksheet
- Divorce Practice: Tips and tricks for common issues (e.g., service of process, situations when spouse cannot be located or is imprisoned, tax issues)
- Legal issues for grandparents raising grandchildren

Health/Benefits, requested topics include:

- Overview of Tenn Care Eligibility Termination System (TEDS)
- CHOICES: Eligibility, including when your client doesn't fit the typical profile
- SSI eligibility and special needs trust
- Identifying and securing benefits for clients who start in other practice areas. (Would cover MSPs, TennCare, disability referrals, SNAP)

- Habitability: Concept/definition/legal requirements

- Land sale contracts and equitable mortgages: What are they and how do you defend them?
- Bankruptcy: Types of relief offered and alternatives to filing

Special Education/Juvenile Justice, requested topics include:

- Implicit bias regarding students with disabilities
- Systematic strategies in special education/section 504
- Functional behavior assessments and behavior intervention plans for students with disabilities
- Criminal justice reform/addressing school to prison pipeline

Elder Law, requested topics include:

- Basic overview of nursing home regulations
- The differences between Medicare/TennCare and eligibility for TennCare/Medicaid
- Conservatorships: Both sides of the fence, obtaining and terminating
- Capacity: Determining capacity and other ethical issues
