NASHVILLE, Tenn., Feb. 17, 2014 – Legal Aid Society of Middle Tennessee and the Cumberland, Tennessee’s largest non-profit law firm, announced today that Barbara Gunn Lartey has joined the firm as victim advocate. Prior to joining Legal Aid Society, Gunn Lartey worked as a bilingual legal advocate at the Tennessee Coalition to End Domestic and Sexual Violence. She has also been a women’s education coordinator and bilingual medical case manager at Nashville Cares and a disability claims examiner at Social Security Disability Services.

“Barbara has experience as an advocate for domestic violence victims and as a women’s education coordinator, as well as a legal background, making her a perfect fit for this position,” said DarKenya Waller, managing attorney for the Nashville office of Legal Aid Society. “She will be a great asset to our firm and to the people we serve.”

Gunn Lartey earned a bachelor’s degree from Oberlin College and a juris doctorate from Temple University School of Law, where she served as editor-in-chief of the Class Action Law School Newspaper. She is a member of the New Jersey Bar Association and is fluent in Spanish. Gunn Lartey also served as an international development volunteer with the Peace Corps in Equatorial Guinea.
