

NALS After Hours Silent Auctions to Benefit LAS

NASHVILLE, Tenn. June 24, 2014 –The Nashville chapter of NALS...the association for legal professionals will host its second annual NALS After Hours Silent Auction event at 6 p.m. Thursday, July 10, 2014, at Baker, Donelson, Bearman, Caldwell and Berkowitz, PC, located at 211 Commerce Street, Suite 800 in Nashville. The event is free and open to the public.

As a way for NALS to give back to the community, one hundred percent of the proceeds generated at the auction will be donated to Legal Aid Society of Middle Tennessee and the Cumberland.

In its first year, the silent auction raised \$3,350 for Legal Aid Society. This year, NALS officials are hoping to raise even more funds by auctioning off items such as autographed memorabilia from the Nashville Predators and Tennessee Titans, hotel accommodations, wine, gift certificates to local restaurants and more.

We could not do what we do without the help from our community.”
