

# TN Supreme Court Justice Holder to Present Inaugural Access to Justice Award

The Tennessee Alliance for Legal Services (TALS) has added the Janice M. Holder Award to its annual Justice Janice M. Holder Access to Justice Awards line-up. The Janice M. Holder Award is named in honor of Tennessee Supreme Court Justice Janice M. Holder (pictured at right), who served as the first female chief justice of the Tennessee Supreme Court, is a passionate leader in Tennessee's Access to Justice initiative, a courageous champion of the rights of the historically marginalized and a dedicated servant to the people of Tennessee. The award recognizes an individual who, like Justice Holder, has advanced the quality of justice statewide, by ensuring that the legal system is open and available to all.
