

LAS Announces 2015 Clinic Schedule

Legal Aid Society to Host 200+ Free Legal Help Clinics Across Middle Tennessee and the Cumberland Plateau

NASHVILLE, Tenn. Jan. 21, 2015 – Legal Aid Society of Middle Tennessee and the Cumberlands announced today that, over the next 12 months, volunteer lawyers and staff will provide free legal help at more than 200 clinics across Middle Tennessee and the Cumberland Plateau.

“These clinics are an approachable and accessible way for individuals and families to get free legal help in their communities,” said Lucinda Smith, director of Legal Aid Society’s Volunteer Lawyers Program. “Because of the commitment from our staff and volunteer attorneys across the region, we are thrilled to once again increase the number of clinics Legal Aid Society will be hosting.”

Most clinics are structured as a walk-in forum, where Middle Tennesseans can receive general legal advice without an appointment.
