**11:10 – 12:10 – Filing Administrative and Office for Civil Rights Complaints:** this session will focus on complaints other than Request for Due Process that attorneys can file on behalf of students with disabilities. Attendees will get hands on experience with a case scenario requiring issue spotting, determining type of complaint to file, identifying remedies, and working in small groups to draft key points in a complaint. **12:10 – 12:50 – Lunch and networking**

**12:50 – 1:50 – Nuts and bolts discussion of how to file a Due Process Complaint;** what happens after the complaint is filed; how to go about settling the case; how a Due Process trial is conducted; and what is required after the trial. It will also include discussion of attorney fees and other post-decision issues. Materials will include samples of Due Process Complaints and scheduling orders. **Presented by Bill Allen**, partner in the Oak Ridge law firm of Mostoller, Stulberg, Whitfield & Allen.

**2:00 – 3:00 – Appeals and post Due Process** – in this final session, we will provide a step-by-step guide on how to file an appeal if you are not satisfied with the outcome of the due process hearing. We will discuss the standard of review used by the state and federal courts for due process appeals, and we will look at a sample complaint. We will also discuss circumstances where exhaustion under IDEA is not necessary, even if some issues are educational in nature, where you can file a lawsuit directly in state or federal court. **Presented by Craig Barnes**, Attorney at Memphis Area Legal Services
