This training will identify some of the most prevalent employment issues facing low-wage workers and will discuss how and where to locate these cases. Many applicants may not realize they have an employment problem, or misidentify the legally actionable claim. Intake can be a powerful tool to reveal employment problems and we will discuss essential information to obtain at intake. Special emphasis will be given to the topics of wage theft and workers' compensation claims, two of the biggest employment problems identified by worker advocates. We will provide an introduction to the process and remedies for addressing wage theft and worker injuries, including bringing Fair Labor Standards Act claims in general sessions court and navigating the workers' compensation administrative process.
