Students are fully integrated into our health and income security teams and participate actively in our work.

We seek applicants with genuine and demonstrated commitment to working for poor and underserved populations, interest in aging issues, high-caliber legal research and writing skills, and the ability to take initiative and work independently. A commitment to a public interest career is desirable.

backgrounds may contribute to more effective representation of low-income people and underserved communities.
