KNOXVILLE – Legal Aid of East Tennessee hosted its Annual Celebrate Pro Bono evening in Knoxville on October 28th. The event, entitled “Forging Justice,” was held at Ironwood Studios in Knoxville and celebrated local attorneys who donated time and civil legal services during the past year to aid those who otherwise could not afford an attorney. Those donating at least 25 hours to LAET’s Pro Bono Project were recognized.

- Pro Bono Partner Award – Knoxville Community Development Corporation (KCDC).
- Pro Bono Advocacy Award – David Gall, Knox Co. Assistant Public Defender.
- Law Firm of the Year – Hodges, Doughty & Carson.

Highlighting the evening was the induction of Douglas A. Blaze into the Donald F. Paine Memorial Pro Bono Hall of Fame. Mr. Blaze. “Doug Blaze epitomizes the dedication to pro bono service and access to justice instilled in our community of lawyers by Don Paine,” commented Dr. Kathryn Ellis, LAET’s Knoxville Pro Bono Project Director. “Doug's involvement extends beyond the city limits of Knoxville. Not only is he active with the Knoxville Bar Association Access to Justice Initiative, but also on the Tennessee Bar Association Access to Justice Committee and the Tennessee Supreme Court Access to Justice Commission, of which he is immediate past chair.”
