

575th TN Attorney joins TN Free Legal Answers!

Tennessee's virtual legal advice clinic, tn.freelegalanswers.org, welcomed its 575th and 576th volunteer attorneys over the Veteran's Day Weekend. Attorneys, who must be authorized to give pro bono advice in Tennessee, login to the website and choose which questions they would like to answer. The questions are posted by vulnerable Tennesseans who make at or below 250% of the federal poverty guidelines. The questions must be about civil legal topics. Throughout October 2016, law schools and bar associations hosted virtual legal advice clinics where attorney volunteers worked together or with law students to help give advice to dozens of Tennesseans with civil legal issues.

TO INCREASE ACCESS TO JUSTICE

Many clients wouldn't ever speak to an attorney if they could not ask civil legal questions through the website.



TO EARN DUAL CLE CREDIT

In TN, attorneys earn 1 hour of DUAL CLE credit for every 5 hours of pro bono they complete.



TO FIT THEIR SCHEDULE

Volunteers can log on and answer a question ANYTIME from ANYWHERE with an internet connection.



TO BE IN CHARGE

Attorneys only give limited scope advice and there are training/resources available for common questions.



TO BE COVERED

Volunteers' interactions through the site are covered by Malpractice Insurance from TALS
